Shareholders are requested to claim the final dividend declared during the FY 2010-11 and onwards before the same is transferred to the IEPF. In case the Company does not receive any communication from the concerned shareholders by 2nd October, 2018 the Company shall with a view to complying with the requirements set out in the Rules, transfer the shares to IEPF by the due date as per procedure stipulated in the Rules.
